

AUTHORIZATION FOR PRE-AUTHORIZED PAYMENTS



ThinkSmart's Pre-Authorized Payment Plan is a convenient way to pay your account and saves you incurring a 2.5% Service Fee for ongoing payments made by credit card. The amount of your payment is automatically withdrawn from your account on the date specified and applied to your lease.

Is there a fee for this service?

- ThinkSmart does not charge you a fee for using this service. In fact, you will avoid incurring a 2.5% Service Fee that is incurred for ongoing payments made by Credit Card. You need to check with your bank for any fees that they may charge. If there are any other applicable fees, such as late charges, you will be billed separately.

How do I know when a payment is taken from my account?

- The payment will appear on your bank statement, showing the amount and the date of the payment.
- The full amount of your payment has to be in your account and available on your payment due date. If the payment is rejected for insufficient or unavailable funds, ThinkSmart reserves the right to charge a fee at our discretion of \$35.
- In the event of the payment rejecting, we will attempt to contact you prior to re-presenting the payment. If this is further declined, ThinkSmart reserves the right to revert to drawing your payments via the existing Credit Card mandate you have provided.
- If your payment due date falls on a weekend or a public holiday, the payment will be processed on the next business day.

If I have an existing ThinkSmart account, what do I need to know about pre-authorized payments?

- Your account must be current to use pre-authorized payments.
- Mail this form with a signed voided check to the address listed below. Once we receive the form, pre-authorized payment requests can take up to ten (10) business days to process.

What if there is a problem or a discrepancy with my payment?

- You need to contact ThinkSmart at the address or phone number listed below.

What if I want to change my bank account information?

- Contact ThinkSmart at the number listed below to request a form to change the account. Allow ten (10) business days for processing.
